# Programmes & Activities During the Year 2020-21

The programmes and activities carried on during the report year were in continuation of the previous years and also some sponsored and funded programmes were initiated which are described below:

## **Micro Enterprise Development Programme**

In 2020-21, NABARD offices of Jharkhand supported us for conducting 2 training programs in Jharkhand for the promotion and development of "village micro enterprises" with a view to promote integrated rural development and securing prosperity in the villages of Jharkhand. Under the program, 15 SHG women were imparted training in 2 batches in trades like Mushroom Cultivation and Poultry also provided them that helped in promoting a sustainable livelihood support for them. ## Farmers Producer Organisation (FPO (under NABARD scheme)

Agriculture is the only major means of livelihood of the entire rural area of the district for which the farmers have been following the traditional and conventional methodologies with conventional equipments, resources and technologies. Due to this, they are lagging behind and facing a lot of problems in their food security. Hence, the organisation took itas a mission to aware, educate and to impart trainings on various aspects for promotion of agriculture. For this, besides organizing the farmers into Farmers' Producer Organisation, several non-conventional processes elaborated to them. For this 10 Gram Sabhas were organised and 4 FPO-Board of Director and CEOs workshops were convened in which multiple topics were elaborated to raise awareness on new techniques of agricultureand horticulture, vegetable farming and Milk Production Milk Parler Production Value addition, lift-irrigation, renovation of old irrigational structures like well, ponds, tanks etc. Other topics included production of vermi composts, organic farming, farming of flowers and medicinal plants, raising kitchengardening, horticultural garden etc.



Collectivization of producers, especially small and marginal farmers, into producer organisations has emerged as one of the most effective pathways to address the many challenges of agriculture but most importantly, improved access to investments, technology and inputs and markets. Department of Agriculture and Cooperation, Ministry of Agriculture, Govt. of India has identified farmer producer organisation registered under the special provisions of the Companies Act, 1956 as the most appropriate institutional form around which to mobilize farmers and build their capacity to collectively leverage their production and marketing strength. This policy document is meant to serve as a reference and guide to Central and State Government agencies which seek to promote and support Farmer Producer Organisations, especially producer companies and linkthem to benefits under various programmes and schemes of the Central and State Governments.

## Household and Community level Issues based Micro Planning

During the meeting the members of Gram Sabhas were made aware about how to identifyproblems, classifying problems and how to prepare micro plans. Micro plans of 1 Gram Sabhas were prepared and later they were submitted in the Panchayat. Out of the submitted plans 5 Gram Sabha's plans of Dobha digging have been approved and the work is in progress. In the meeting problems of Indira Awas, Widow Pension, Old Age Pension, Village Road Construction and the Non-pest farming being done in the area were discussed. This programme was carried out in 05 villages.

# Developing girls as local leaders cum trainers through Life skill

Orientation Training Life skills are essentially those abilities that help promote mental well-being, decision making capacity and competence in young people as they face the realities of life. Life skills education is a participatory learning that aims to increase positive and adaptive behavior by assisting individuals to develop and practice psycho-social skills that minimize risk factors and maximize protective factors. Life Skills knowledge has been effective in strengthening girls' negotiation skills on issues such as marriage. It helps the girls in understanding the importance & priority of the issues and taking appropriate decision related to basic rights, primary health care, personal health & hygienic practices.

## NABARD-LEDP Programme - Jamtara



Training and demonstration on Vermi Compost –Bio



This training cum demonstration program was organized at Sabanpur panchyat during 27 January and 02 March 2021. The training was attended by 150 community persons. The participants were told about the importance of organic farming and how to make vermin compost, Jiwamrit Khad, Ghanamrit Khad and Jhatpat Khad in detail. Apart from this participants were also told about the method of making organic pesticide with the aid of Tobacco leaf, Cow urine, Garlic and Pota leaf. The participants also did practical on the subjects they were told theoretically. Awareness& Training Low cost vermin compost for easy replication Awareness & Training



on Low cost vermin compost: A training programme on low cost vermin compost making was organised 150 participants has been trained from 27/01/2021 to 02/03/2021 in 3 (three) separate venues i.e. (i) Madhya Vidayalaya Sabanpur (ii) Panchyat Bhawan Sabanpur and (iii) Madhya Vidayalaya Madhuban in the first phase.

## SHG digitisation and Strengthening: (under NABARD scheme)

SHG formation and strengthening and digitisation has been the focussed programme of Gram Sathi and is being carried on in deoghar district in Jharkhand State under support of NABARD, Govt. of India. So far, 510 new women's SHGs have been digitisation under assistance of NABARD, Ranchi. SHGs under NABARD, Ranchi. During this year 510 SHGs have been digitisation and efforts are being made for linkage with Banks. They have also been given trainingon various aspects like maintenance of by-laws, book keeping, proceeding writing, accounts keeping, entrepreneurship development, problem solutions, literacy promotion and resolving such other local problems and issues by mutual discussions in their groups.

## Rural Mart setting up : (Under NABARD Scheme)



Rural Mart is the lifeline of the economic activities of the , vendors, small producers, SHG members for selling their goods like Bandhana Boutique Flower Pot Lac bangles Tasar grand Silk Jute Bags etc Products and products for their livelihoods and the buyers to purchase their needful items. Almost all types of things are sold and bought in rural Mart. Such Rural Mart's members are on Shops

almost all places within convenient distance. In view of needs of the Ajmeri Self Help Group and other SHGs a Rural Mart is constructed by gram sathi in deoghar district head quarter.

## **Integrated Livelihoods Development Centers**

India's rural economy depends on agriculture as its backbone, in addition to which, cattle rearing plays a major role in helping our farmers earn their daily livelihoods., the farmers of Godda district were observed to be engaged in cattle-rearing, but deriving very little from it financially, owing to the dry climate affecting green fodder availability, lack of scientific cattle-management practices and unavailability of trained veterinarian service providers.

Against this backdrop, the Integrated Livelihoods Development Centres project was initiated in January 2020 in Godda district, Jharkhand, with the objective of enhancing livelihood opportunities through FPO improved livestock management and cattle development. The project has set up, operationalized and run 21 ILDCs, which to this day, function as village-basedveterinarian clinics. These centers are managed by 05 rural youth, identified and trained as para- veterinarians, working under the name - Tulshi and providing a range of preventive and curative healthcare services round the clock, such as deworming, deticking, vaccination, fodder plot inputs, infertility treatments and cattle health-camps etc.

## Relief for Migrant Labourers

Watershed Management Amid Lockdown As India went under lockdown, several villagers originally from areas such as Sariyahat dist Dumka were forced to undertake arduous journeys back home - via multiple means of transport, and on foot. Moreover, residents needing to find work in cities, found themselves stuck at home, with no means of employment. With the aim to ease the situation to the extent possible, Gram Sathi on-ground team took this matter to the BDO, tehsildar and officers in-charge of MGNREGA in the region. Within a few days, with the paperwork in place, several labourers found work in their own villages. In Bagmari and Parasdha under the MGNREGA scheme, over 100 workers were engaged in several watershed management and environment restoration efforts - such as watering saplings, building CCTs, loose boulder structures, compartment bunding, etc. Similarly, hundreds of other villagers found work in their own villages, in other talukas participating in the Place.

## **Activities taken under COVID-19**



Gram Sathi - Based in Bihar & Jharkhand State, the organisation aims to provide socio-economic and psychological support to the rural people living in the areas of Banka, Katoriya, of Bihar state and Deoghar, Dumka, and Godda in Jharkhand state. Currently, we have provided food and water dry ration like rice, atta, sugar, bathing soap, oil, detergent powder, tea, masks etc among 1100 families these families belongs to the most deprived. In the upcoming months during lockdown period we will provide support to vulnerable families.

Gram Sathi have stepped forward to provide food, health, and sanitation support. For unregistered workers and those who are just not able to access free rations from PDS shops, Gram Sathi and its many partners have stepped forward to meet food and other survival requirements. Since 25th March when the national lockdown was announced, 1100 food kits, paying special attention to the nutrition requirements of children under six years. Gram Sathi has developed a remote support program that covers the following aspects: the wellbeing of families and immediate requirements; simple COVID-19 awarenessmessages for children; ageappropriate play-based early learning activities; and bank of poems and stories for children.

- ❖ Integrated Watershed Project covering 15 villages, 120 hectares land in 01 block of Dumka district.
- ❖ A new pond (100'x 100'x') construction on land of Mr. basant humbram in Parasdha village of Saraiyahat block.
- ❖ The pond ensured irrigation of 4.5 hectares land of 9 farmers, useful for Rabi & Kharif crops with possible income of Rs. 195000 annually.
- ❖ A new Dova (60'x 60'x') construction on land of Mr. Mistri Tudu in Khirdhana village of Saraiyahat block.
- ❖ The Dova ensured irrigation of 4.5 hectares land of 60 farmers, useful for Rabi & Kharif crops with possible income of Rs. 125000 annually.
- Trench Cum Bed (TCB) of digging in 5 villages of Saraiyahat block, useful for ground water recharging in 40 hectares barren land of 58 farmers.
