Banka district is full of problems on all scores of life i.e. hilly – rock land, diminishing forest, huge rain or total drought, no storage facility or reservoir of rain- water, lock of irrigational resources, lack of cultivable land, migration and unemployment of yours.

To reduce these problems through community participation and support, Gram Sathi emerged in the year 2007 promoted by a group of social workers and activists through organized and sincere efforts to address the grass root community issues with special forcus to the poor and resource lees people living in the rural and slum areas of Banka and Bhagalpur district in Bihar.Later on our activiyies spread to Deoghar, Godda, Dumka, Pakur and Sahibganj districts in Jharkhand.

Since inception, Gram Sathi has undertaken various community cantered programs by putting the last first involved in the development process. Bringing social change through community mobilization and social action is our highest priority

22. Recruitment Policy.

There is an internal team for recruitment of staffs which consists of five members and is headed by the Secretary himself. This committee is called Recruitment Committee. The other members of the Recruitment Committee are the Concerned Project In charge and the members of the Governing Board. In Requirement process first application is applied for the concerned post and on basis of post requirement the application is short Listed by project in charge and director, then candidates are informed for the interview and the suitable condidates are selected. There are some fixed criteria for the selection of candidates like qualifications and experiences etc. The selected candidates are briefed about the rules and regulations of the organization and are asked to sign the agreement. The other signatory of the agreement is Secretary himself. The agreement is for once years only and is extended according to the performance of the staff or extension of the project.

23. MAJOR OBJECTIVES

- To strengthen community driven initiatives for people empowerment, sustainable livelihood, health management, total literacy and holistic development of the community in general with an emphasis on the poor and marginalized sections of the society.
- To protect child rights through various programs for child labor, Child marriage and child trafficking.
- To promote natural resource management, agriculture improvisation, safe drinking water, agro-forestry and environment conservation measures,.
- To protect disabled people and old aged people through programs on health and rehabilitation measures.
- To protect women in distress to bring them into the mainstream of life.
- To develop leadership and capacity of the youth and adolescent for participation in the development process.
- To capacitate community based groups, women SHG in particular for advocacy and social mobilization for actualization of development process among the community.
- Reproductive Health -improved SHR services/ provision of high quality youth friendly SRH services (YFS).
- Sex Education-Comprehensive and informed sexuality Education that the youth can rely on.
- Advocacy-combating / Fighting sexual and gender-based violence among youth and society at large.
- Engaging stakeholders to promote sexual and reproductive rights.
- To provide technical knowhow and skills through vocational training and other capacity development programs for livelihood promotion and dissemination of information for local resource management and conservation of traditional system for improving the quality of life and living standards of the people.
- To promote strong network of voluntary organizations at the district, state and national levels for working on the common issues based on local situations at various level.

24. Finance & its Management

- Finance is managed from various sources : local community, members & associates, donors, beneficiaries, funding partners — national as well as international,
- Financial management is maintained through (i) Accounting system and (ii) Administrative system.
- Due trainings on financial activities, book-keeping, record-keeping etc. are given to all staffs and members from time-to-time and orientation trainings are also given to them.
- Proper planning of activities, strategic planning, budgeting, monitoring, internal controls, Book-keeping (including day-book, cash-book, bank-book, ledger, stock-book, vouchers, bank accounts, quotations and such other documents are maintained and are examined from time-to-time.
- Bank accounts are maintained by joint operation of the office bearers as per the resolutions taken by the Trust Committee and also according to the instructions of the funding agencies, if any.
- Separate bank account under FCRA provisions is operative by the joint signatures of the office bearers.
- Trust Committee, Managing Trustee, finance section, accountant, Treasurer and all other related staffs and

personnel have been entrusted to observe norms of financial management.

- At the close of every year financial activities for the year are summed up and action plan for the next year alongwith the anticipated Budget is prepared.
- Yearly and periodical accounts are prepared and are got approved by the Trust Committee as well as by the Funding Organizations.
- Unit-wise accounts are audited after the completion of the projects and program me`s.
- Financial activities of the organization are regularly audited on yearly basis by the qualified Chartered Accountants appointed by the Trust Committee simultaneously.
- Proper returns are filed with the Income-Tax Department, Ministry of Home Affairs (FCRA) and other departments and authorities concerned.
- All legal formalities of the land and the instructions of the Funding Agencies are observed sincerely.
